ORDER

The Government of India had reconstituted the Central Advisory Board of Education (CABE) vide Resolution dated 12 December, 2008. The 56<sup>th</sup> Meeting of the CABE was held on 31<sup>st</sup> August, 2009 wherein it was recommended that a Sub-Committee be set up on ICT in School Education. Accordingly, it has been decided, with the approval of the Minister of Human Resource Development, to set up a “**Sub-Committee of CABE on ICT in School Education**” with the following composition :-

2. The terms of reference of the Sub-Committee are :-
- (i) To suggest guidelines for use of ICT in school education
  - (ii) To suggest possible role of public private partnership in use of ICT in education for ICT literacy as well as ICT-aided education
  - (iii) To suggest the appropriate level for introduction of computer literacy among school students
  - (iv) To suggest the role of ICT in skill development at the school education stage
  - (v) To suggest appropriate pupil computer ratio in different stages of school education
  - (vi) To suggest strategies for teachers capacity building in ICT usage.
  - (vii) To suggest strategies for development, dissemination and effective use of digital content.

3. The Sub-Committee shall be provided the secretarial assistance by NCERT. The Members of the Committee shall be paid TA/DA at the rate that are payable to the Members of the High Powered Committees by NCERT.
4. The Sub-Committee shall give its recommendations within six months from the date of its constitution.
