The power and functions of the Arunachal Pradesh State Commission for Protection of Child Rights (APSCPCR) shall be governed by the provisions of the Commissions for Protection of Child Rights Act, 2005 (No. 4 of 2006) and conditions of services, except salary and other allowances, in respect of the Chairperson, Vice-Chairperson and Members of the said State Commission shall be regulated in terms of the Government Notification No. WCD-26/02 (SWC) dated 8th December, 2004 until the Arunachal Pradesh State Commission for Protection of Child Rights Rules are framed by the Government. The term of office of the Chairperson, Vice-Chairperson and Members of Arunachal Pradesh State Commission for Protection of Child Rights (APSCPCR) shall be co-terminus with term of Arunachal Pradesh State Commission for Women (APSCW) or till the nomination of independents whenever is earlier Chairperson and Members.
