

Sir,

In continuation of this Ministry's sanction letter dated 14th August, 2012 and 27th May, 2013, I am directed to convey the sanction of the President of India to the payment of central assistance (Non-recurring) of Rs. 46,66,000/- (Rs. Forty Six Lakh and Sixty Six Thousand only) as balance payment of second installment against the approved cost of the proposal amounting to Rs. 3,73,41,000/- (75% Central Government share).

2. The expenditure involved is debitable to Demand No.51-Department of School Education and Literacy – Major Head '3601 Grants-in-Aid to State Government 02-Grants for State Plan Scheme, 165-Elementary Education-Other Grants, 02-Development of Minorities; Education Scheme for Madarasas/ Minorities, 01-Scheme for Providing Education to Madarasas/ Minorities; 02.01.35-Grants for creation of Capital assets (Plan) after re-appropriation from Major Head '2552' Grant-in-Aid to North Eastern Areas-00-156 'Elementary Education- Other Expenditure- '17' - Development of Minorities: Education Scheme for Madarasas/ Minorities- '01' – Scheme for Providing Education to Madarasas/ Minorities- '35' Grants for creation of Capital Assets 2016-17.


